

**Parental Confidentiality Agreement and Waiver of Liability On Behalf of a Minor**

Inventionland, LLC, on behalf of itself and other occupants and sub-lessees of the Facility (collectively "Inventionland"), grants limited access to the facility located at 585 Alpha Drive, RIDC Park, Pittsburgh, PA (the "Facility") to \_\_\_\_\_ ("Visitor"), a minor, in exchange for the agreement by Visitor's parent or legal guardian to the terms of access and confidentiality below:

Visitor acknowledges that while in the Facility he/she will be exposed to business operations and methods of Inventionland and new products under development that Inventionland maintains as trade secrets and/or confidential and proprietary business information both for itself and for its clients. Visitor agrees that he/she will not discuss, disclose or reveal any information concerning any product under development within the Facility or Inventionland's methods of business operation and product development.

Visitor agrees to obey the limits of access, to refrain from entering any area to which access is not expressly granted and to leave the Facility immediately if directed to do so by an Inventionland representative. Visitor agrees to refrain from recording sound or photographing or video-recording images in the Facility by any means. Visitor consents and acknowledges that Inventionland may record Visitor's image and voice while in the Facility and consents to Inventionland's use of the images and sound recorded for any lawful commercial purpose, including the marketing and advertising of Inventionland's services and products.

As parent or legal guardian of Visitor, I understand the conditions of access contained in this document, will abide by them and will make all reasonable efforts to ensure that my child abides by them. As parent or legal guardian of Visitor, I acknowledge the risks inherent in the tour or use of the Facility and assume all responsibility for any harm that Visitor may suffer, including harm cause by the negligence of employees and agents of Inventionland or others. On behalf of myself and Visitor, I covenant not to sue and release, discharge and waive Inventionland, its owners, agents, contractors, employees, officers and directors, and the owners, agents, contractors, employees, officers and directors of the persons or entities owning, occupying visiting or using the Facility, from all claims and liability to myself and to Visitor for any loss, injury or damage whatsoever incurred by myself or Visitor while visiting the Facility.

I acknowledge that I have read this release and waiver of liability, fully understand its terms and its impact on my rights and on Visitor's rights and agree to its terms freely. I intend this agreement to be a complete and unconditional release and waiver of all liability to the fullest extent permitted by law.
